Under no circumstances will the shuttle wait on you to arrive (or for the return trip, leave earlier or later than scheduled for the club's return flight). The ski club will not be responsible for providing or paying for a separate shuttle to the resort. It is strongly encouraged that before you decide to make your own air arrangements, that you include the cost of ground transportation, as you may not be able to use the club's shuttle.

## CANCELLATION POLICY

The Drop Date or the date by which I must cancel and get any refund is NOVEMBER 5, 2024. Even before the Drop Date I understand that I will be liable for (1) any fees charged by the resort and/or transporter(s) as a result of cancellation, and (2) any increase in cost to the Chattanooga Ski Club resulting from the cancellation. The minimum cancellation fee is \$100. All trip cancellations revert to the club for resale purposes. All credit card fees are nonrefundable.
